Article 2- Offer If an offer has a limited validity or has other specifications, this will be emphatically mentioned.

Article 3- Right of Withdrawal

After online purchasing products the consumer has the possibility to disband the agreement without giving reasons during 7 days. The cooling off period starts on the day after the consumer receives the product or a pre-designated representative by the consumer made known to the entrepreneur.

During the cooling off period the consumer shall treat the product and the package carefully. He shall unpack or use the product only to that extent to as far as it is necessary to judge if he wishes to keep the product. If the consumer has made a payment, the entrepreneur shall pay back this amount as soon as possible but no later than within 14 days after the return shipment has received the entrepreneur.

Article 5- Pricing

Article 6- Conformity and Guarantees
